- 4.1 Treasurer's Report CHRISTINA MENSSA
 - Current balance of \$71,566.69
 - Monies still to be transferred into the Wolf Creek trust account for the new playground.
 - Dueling piano night brought in a \$36,926 profit.
 - ATB Round Up raised \$ 23,198, with more monies still coming in.
 - Rotary Club donated \$10,000 from an international grant to the new playground.
 - The Society purchased insurance from the Co-operators for \$2,000 and insurance is now in effect. Will have to be renewed in one year.
 - Huge thank you to Christina for all her work throughout the year from the Board.
- 4.2 Playground Committee Report JEN BARTLEY
 - Hafla coming up Saturday, Sept. 19 with proceeds going to playground.
 - Charity hockey game in the new year Thursday, January 21, 2016. Looking for parents/players to make our team. Looking for sponsors to sponsor the players, raffles, silent auctions, games, etc. Adult players only for this event, family event to attend. PD day Friday following the event.  - Some special order equipment has been ordered for the new playground. All Kompan brand equipment, including SkyWalk.
 - Discussing with WCPS Facility Dept. and Private Donor possible hill/ hills for around edge of playground. Nicole Rawlinson brought up possible concerns with supervision on the playground and not being able to see the back side of the hill. More discussion to come.
 - When and how are we relocating our existing playground equipment? Brad Buss to speak with Blue IMP (old playground equipment). Brad to look into costs and such to move equipment.
 - Rotary grant successful for \$10,000
